Through its numerous membership services, the Council works in conjunction with colleges, universities, and agencies that host TRiO Programs to specifically help low-income Americans enter college and graduate. #### **President's Summary of Accomplishments**

ASPIRE Inc's mission is to increase the educational and success opportunities for low-income and first-generation college students through professional development and legislative advocacy. The work of ASPIRE's membership, committee chairs, state presidents, and executive board over the last year compiles to quite a list of accomplishments toward that two fold mission.

#### Professional Development Accomplishments for 2010-2011:

- 25% of regional membership revenue was granted back to the states to fund professional development at the state level (or other purposes as approved by the state association).
- Six state meetings were held in the spring. The regional president personally attended and presented at the meetings held in Montana, North Dakota, South Dakota and Utah. The president presented via Skype at the Colorado meeting, and the regional president elect attended the Wyoming meeting.
- Several members of ASPIRE attended the Leadership Summit in Washington DC prior to Policy Seminar.
- ASPIRE's annual Leadership Development Institute will be held October 8-9, 2011.
- Two half-day, pre-conference workshops will be held prior to the regional conference. Topics covered are: TRIO Program Evaluation Techniques, and Using Census Data in Grant Writing and Community Needs Assessment.
- Regional conference will be held October 9-12, 2011 in Salt Lake City, UT, with representatives from COE and Department of Education on the agenda.

#### Legislative Advocacy Accomplishments for 2010-2011:

- ASPIRE offered matching funds to all six states to conduct state initiative activities. Three states applied for and received the matching funds.
- Three ASPIRE states were awarded matching funds from COE to conduct state initiative activities.
- Granted travel stipends to state presidents to attend COE Policy Seminar and meet with congressional leaders.
- Hosting regular conference call meetings with representatives of all six states to discuss strategies and progress being made to gain and build legislative support for TRIO and GearUp programs.
- ASPIRE members attended several Town Hall meetings across the region during the fall legislative recess.
- ASPIRE members attended a roundtable discussion held by Arnie Duncan, Secretary of Education, in South Dakota.

#### Other Accomplishments for 2010-2011:

- ASPIRE remained a valued and supportive region to COE by:
  - Meeting 136% (\$224,547.38 of \$165,377 goal) of COE Fair share, with all six states exceeding their goals: CO 133%, MT 110%, ND 162%, SD 134%, UT 150%, WY 166%.
  - o Michael Wade served as COE Treasurer (2009-2011).
  - o Amy Verlanic elected as COE Treasurer (2011-2012).

- Dawn Eckhardt served on the By-laws, Governmental Relations, Resource Development, and Strategic Planning Committees, and chaired the Personnel Committee.
- o Rachel Martinez served on the Conference, Governmental Relations and TRIO Achievers & Alumni committees.
- Lynne Brown served on the Governmental Relations, International Access, and State Leadership committees.

#### Colorado State Report 2010-2011:

#### Membership & Recruitment:

We currently have over 250 TRiO employees in the state of Colorado, and our current membership is 150. To offer better communication throughout the state and to increase membership, we email everyone in the state even those who are not current members of ASPIRE and we encourage them to become members. I have seen a positive outcome to this new process because I have newly hired staff emailing me on now to become a member. Our old system would just email paid members, but as President I established this new system where we email all state TRiO employees and ask directors to let us know when they have hired someone new. I also personally email staff that are inactive and encourage them to join and participate in our state's professional development and conferences.

#### Alumni Development:

Colorado holds an annual barbeque on the CSU-Ft. Collins campus in the fall season for all Colorado TRiO Alumni and current participants.

#### State Meeting/Conference:

This year, we moved the state meeting from Denver to Pueblo, Colorado to try and accommodate everyone in the state. We had one of the highest participations rates within the past three years. We had 90 Registrants with 87 present for the conference. During this conference we invited our newly appointed Lt. Governor Joe Garcia to come and speak during our luncheon. The Lt. Governor's office is in charge of the states Department of Higher Education and we were lucky enough that Lt. Governor Garcia gladly accepted our invitation.

He encouraged us to stand strong and persevere even though there are budget cuts. He fully supports TRiO programs and gave us hope for a better outcome for our state. A representative from Senator Mark Udall's office and a representative from Senator Michael Bennet's office were also present for our TRiO achiever's luncheon.

We had two workshops in the afternoon presented by College in Colorado on Education Cents and Challenge Access Grants for our state.

#### Fund Development:

We exceeded 100% Fairshare in 2010-2011. We did have over 10 contributors to COE, however we did not meet our \$10 for 10 campaign in time for a free policy seminar registration.

#### Leadership Development:

During our official state meeting on Friday April 29, 2011, we elected a president-elect, a treasurer, two representatives at large and one support staff. We have encouraged members to attend the LDI Seminar in Utah and I believe we will have at least three new members attend.

#### Government Relations:

Our state initiatives team is highly involved at the state level. Oscar Felix, the chairperson is always on the lookout for events where TRiO can be at the table. This past year Oscar and his team orchestrated a "Meet & Greet" reception for local representatives to join TRiO for dinner and discuss the future of education in our state and how TRiO changes student's lives every day. Those in attendance were Jim Reisberg, from Greeley and Randy Fisher from Ft. Collins. Gully Stanford from College in Colorado was also present. Our state initiatives committee also attended a "Day at the Capital" on February 10, 2011 as part of the Colorado Counselors Association Annual event. During this event, Colorado TRiO programs have access to a productive lobbyist firm Salazar & Associates who has a history in moving education forward in our state.

#### PR & Marketing:

Our fact book was re-created and used during one of our state initiatives functions in February, we took them to policy in March, and we handed them out to our membership at our state conference in April. State Fact Book was given to Federal and State legislators and our state fact book is being distributed throughout Colorado through our membership. At our state conference, the board encouraged all projects to deliver fact books to their communities and local representatives.

The Colorado ASPIRE website was updated with current information and is user friendly.

#### **State News:**

- The South Dakota TRiO Day reception took place at the state capital in Pierre, SD on March 1<sup>st</sup> from 10:30am to 12:00pm. TRIO professionals, program participants and alumni from across the state gathered with state legislators, cabinet members, constitutional officers and interested public to promote TRIO programs and their impact on education in South Dakota.
- SD ASPIRE President, Cody McMichael, USD Upward Bound Advisor, Aaron Poor Bear and two TRIO alumni met with the South Dakota legislative team in Washington, D.C. in March as part of COE's Policy Seminar. The South Dakota ASPIRE team effectively advocated for increases in TRIO funding.
- Tina Hartley, Assistant Director of Student Support Services at Dakota Wesleyan University will assume her two-year term as president in the October 2011.
- Cody McMichael, President of the South Dakota Chapter of ASPIRE, submitted an
  application for the COE State Initiative Grant. The grant application was accepted, and is
  funded at \$1480. COE Initiative Grant funds were used to print the South Dakota TRIO
  Fact Book and help promote SD TRIO programs at the state TRIO Day reception at the
  state capitol.
- The South Dakota ASPIRE state conference was held in Chamberlain, SD, April 18-2, 2011. It provided 32 TRIO professionals in South Dakota with valuable networking and professional development opportunities. General sessions provided valuable information on TRIO advocacy, public relations, alumni and financial literacy.
- TRIO staff from across the state volunteered for the College Goal Sunday event that was held February 23, 2010. TRIO staff volunteered their time, energies, and expertise to make this a very successful event.

- TRIO personnel from across the state of South Dakota volunteered at College Goal Sunday events held in seven locations around the state.

- South Dakota finished the membership year with 48 members, 42 of which were professional members of ASPIRE.
- The annual South Dakota ASPIRE spring conference was completely paid for in registration fees. Additional funds were generated through a silent auction and raffle at the conference.
- The South Dakota Chapter of ASPIRE financial goals include meeting ASPIRE/COE Fair Share goals every year.
- The South Dakota Chapter of ASPIRE to the ASPIRE region basket to be used as a fund-raiser at the COE Annual Conference in San Diego.
- Carol Gritts (Upward Bound Director BHSU) made a concerted effort into securing COE project memberships with those programs who have not supported TRIO in this way.
- Personal donations from SD ASPIRE members to ASPIRE were above average for the year.

## Strategic Goal # 3: <u>Provide professional development opportunities to the members of ASPIRE.</u>

#### **Activities/Accomplishments:**

- Several workshops, covering a wide variety of topics, were offered at the SD ASPIRE state conference held in Chamberlain, SD, April 10-12.
  - o Professional development sessions included:
    - Dusty Johnson, chief of staff for Governor Daugaard, was the keynote speaker at the state conference. Trio professionals had an opportunity to ask questions and promote Trio to one of the top government officials in the state
    - Non-Trio staff from Great Lakes Higher Education presented a session on Financial Literacy.
    - A general session on developing alumni relations was presented by DWU Trio Director, Kate Miller.
    - A general session teleconference with Alvin Phillips. Carol Gritts updated SD Trio programs on the importance of meeting Fair Share and where the state was in reaching the goal of 100%.
- Professional development opportunities have been assigned to South Dakota ASPIRE
  members who volunteered their services and expertise on standing committees and
  leadership positions of South Dakota ASPIRE.

## MEMBERSHIP/LEADERSHIP/STATE MEETINGS AND CONFERENCE DEVELOPMENT

In an effort to increase state membership, ASPIRE Utah offered a reduced registration rate at the state conference for ASPIRE Utah members. All TRiO and GEAR UP staff in the state were invited to attend. Approximately 70% of the state membership attended the spring conference, and an additional 14 attendees chose to pay the higher registration rate rather than become members. State conference workshop presentations were run by TRiO and Non-TRiO personnel.

We extended invitations to our congressmen and senators and were pleased to have a representative from Senator Hatch's office attend our State TRiO Achievers Luncheon.

With the passage of our State Bylaws and Operating Guidelines this past December, we have instituted a ceremony for the succession of officers, which will help to outline the duties and responsibilities of the ASPIRE State Board of Directors. Not only is this information available to the membership via the State website, it is to be repeated annually at the swearing in of officers to remind new leaders and the membership alike of the responsibilities being placed on the shoulders of their leaders. This, along with informal training of Past-Presidents, will help to create a sense of continuity in our State leadership.

#### **ALUMNI DEVELOPMENT**

ASPIRE Utah is proud to be hosting the Regional ASPIRE Conference this coming October. As a part of the annual conference, we are hosting our first ever Regional Alumni

Conference – a one-day event that will run alongside the opening day activities of the regular conference. Though difficult to brag about at this point, we as a state are very excited for the Alumni event and have been putting a lot of thought and planning into ensuring it's success.

#### **FUND DEVELOPMENT**

As the ASPIRE Region is still working toward achieving a 501c3 status that will encompass the state chapters, it is difficult to do direct fundraising. Despite this limitation, we have received support from Carl Porter, Director of Academic Support Centers and Programs at Weber State University in the form of matching monies for our TRiO Day/State Policy Seminar this past February. Additionally we were awarded a Regional State Initiative grant in the amount of \$250.

Also notable are the fundraising efforts being conducted by the corporate development committee for the upcoming Regional Conference to be held in Salt Lake City. Though technically a Regional committee, all on the committee are Utah ASPIRE members. As of August the committee has generated over \$4500 in donations, with more monies expected to come in by October.

#### **GOVERNMENT RELATIONS CRITERIA**

This past year, Utah held its first ever state Policy seminar in conjunction with our annual TRiO Day. In the morning we held workshops focused on TRiO advocacy and civic engagement. TRiO staff, students, and alumni from around the state were in attendance. Additionally, we had representatives from Senator Hatch's office, as well as from Congressman Bishop's and Congressman Chaffetz' offices. The representatives held an open forum Q&A during the morning workshop sessions.

In the afternoon we held a luncheon where the legislative representatives heard from Utah state-level TRiO achievers.

#### **PUBLIC RELATIONS & MARKETING CRITERIA**

Thanks in part to some matching funds received through a Regional State Initiative grant, Utah has developed a state ASPIRE website. A former TRiO Talent Search student volunteered to compile information for the website, which was then uploaded to

http://www.ASPIREut.org. The site has a digital newsfeed of current happening in TRiO statewide, pictures of events, and a link to our current Fact Book. The site has links for various audiences, including staff, students, alumni, and legislators or interested parties.

Planning and preparation for the ASPIRE 2011 regional conference is underway thanks to an amazing group of volunteers. The sub-committee chairs are working hard to finalize the small details in order to ensure that this year"s conference is a success. The following sub-committee reports have been provided for review by the ASPIRE Board:

Agenda & Conference Program – Kathy Felker distributed and collected the calls for proposals of presenters. At first there was some hesitation to commit because of the funding status of the TS and EOC grants. However, we now have more proposals than we can accommodate and Kathy is in the process of eliminating "filler" sessions such as round tables. A variety of topics will be offered during each breakout session, meeting the needs of administrators, advisors, and personal/professional development. To save money, this year we decided to use 3-ring binders with inside pockets for materials and printing "in-house" instead of purchasing conference bags and ordering spiral-bound programs. Information for the agenda booklet has been collected from a variety of sources, and Kathy is working with Krystal, Julianna Larson (Awards), and myself in creating the complete conference program.

**Corporate Development** – To date, this committee (which was led by Dorothy Hill, then handed over to Ruth Stubbs after Dorothy accepted a position outside of ASPIRE) has raised \$4,150 through the WSU Diversity Office, Utah Higher Ed, the Franklin & Elizabeth Alex Foundation, and two

personal donations secured by Dave Trujillo. One thing that we tried this year was seeking contributions from universities within the state of Utah. A letter was sent out to all program directors at each campus asking them to approach their respective administration and request a donation of \$500. Our goal was collect a donation from each university, which would have contributed an additional \$6500 to the conference. However, we were only able to collect one donation due to tight budgets across the state.

Conference Ads & Vendor Booths: This sub-committee (Sheldon) under Corporate Development is working closely with Krystal (Conference Program) and is in the process of collecting all ads from the region and states, as well as individual programs and vendors. Requests were sent to TRIO programs and higher education institutions across the region, as well as individual businesses, via the ASPIRE listsery. Many ads have been received, with a final acceptance date being late September. A full accounting of ads received and revenue generated will be provided as part of the conference report following the conclusion of the 2011 conference.

#### Entertainment –

*President's Reception/Other*: Lindsay Beddes suggested a former TS student of hers who is a beautiful folk singer/songwriter. She and her father are huge TRIO supporters and she volunteered to play at the reception for free (although we will pass around a tip jar for her). Lindsay is also organizing the annual Pub Crawl and will have details secured in the next week.

Awards Banquet – Adrienne is in the process of securing the DJ/Karaoke event. She has a student who has DJed at several other functions and is working with him to finalize details. Also, Oscar Felix is stepping down this year as the banquet MC and Rachel Martinez has volunteered to take his place. Andrea Reeve is planning on performing the induction ceremony again.

Fun Run – Tami and Luke have been mapping out several different routes in the SLC area. Since transportation to SLC area parks is an issue, they are looking at routes that are within walking distance of the hotel. The cost for this is \$10 which includes a T-shirt with the conference logo on the front, and to date, we have 26 registered.

Oktoberfest – I have been working closely with Nancy Cannon to organize an excursion to the Oktoberfest festival at Snowbird Ski & Summer Resort. The fee is \$15, which will go towards the cost of fuel. Nancy has reserved three minivans from Enterprise Rental agency, with a rate of \$50 per van. Several colleagues had volunteered to use their state vehicles, but as I discussed this further with Kathy, she informed me that it was illegal to use state vehicles for transportation; furthermore, we did not want to ruffle feathers by having state vehicles with institution logos be seen at this particular event. This excursion is optional and currently we have 16 people registered, with a cap of 24.

**Evaluations** – Lindsay has been working on putting together a draft of questions that will be used to create an evaluation for each session, and the conference overall. This year we are trying a new online tool called Student Voice. Lindsay is very familiar with it and expects that more people will participate in the evaluations since they can pick and choose the evaluation for the specific session that they attended. This will also eliminate the need for paper evaluations at each session.

**Special Guests** – Invited speakers for the conference included Dr. Arnold Mitchem, Dr. Linda Byrd-Johnson, Jonathan McKenzie, and Lucy Jones. With the exception of Dr. Byrd-Johnson, all special guests are confirmed to attend and all hotel and travel arrangements have been made. Dr. Byrd-Johnson would like to attend but has not yet confirmed.

**Head Table** – Donalynn has received a list of names of the board and all special guests, and is working on creating the "table tents" for each session.

**Moderators** – A call for moderators will be sent out on Monday. Carol will conduct the moderator training on Sunday, October 9 from 1:30-2:00.

**Raffle** – Kristina and her committee are asking for donations for the raffle. An email was sent to each state president asking to donate a "theme basket" or one "large ticket item" of their choosing. In addition, Donalynn Sessions has donated a quilt. Kristina is also working on securing smaller items to be given away as a "daily door prize". Unfortunately, due to limited budgets and the poor economy, businesses have been hesitant to donate larger, more expensive items.

**Registration** – Dawn Eckhardt developed the registration site on C-vent. Invitations to register for the conference were sent via C-vent, the ASPIRE and TRIO listservs, as well as flyers to all programs in the region. This year the conference is offering One-day registrations to those who cannot commit to attending the entire conference, as well as a special Retiree fee. To date 221 people have registered for the conference, and Lynne Brown has been collecting all payments. Barb Burkart will be working at the registration desk for the purposes of on-site registration, check-in, payments, and membership.

**Silent Auction** – Lori Larson has sent out several emails reminding people to bring items to the silent auction. Claudia will have the forms on site for people to fill out.

**Budget** – I have been in constant contact with John, making sure all payments have been received and accounted for.

**Logistics** – Adrienne and Colin met with the Radisson and became familiar with all rooms and meeting spaces. They are working with the hotel to make sure all details of the conference are covered. With minor changes, rooms, meals, decorations, equipment, and a host of other details are being finalized this week.

Pre-conference and Community Service Projects – Nancy secured three pre-con workshops. Lucy Jones will conduct a 9-2 workshop titled "TRIO Program Evaluation Techniques" on Saturday, October 8th. Tim Border, who is a TRIO Achiever this year, is holding a half-day pre-con on Sunday morning titled "Building an Organizational Culture within TRiO Programs". The other Sunday morning pre-con will be offered by the US Census titled "Using Census Data in Grant Writing and Community Needs Assessment." In addition, Nancy organized two community service projects that ASPIRE participants can volunteer at their leisure. We will assembling hygiene kits for the Days for Girls International organization as well as writing letters and Christmas cards for care packages that will be assembled and sent to soldiers serving our nation. The times are Monday, October 10th from 11am - 4pm and Tuesday, October 11th from 11am - 3pm. The Community Service Project room will be open during those times for any and all who wish to volunteer their time when they have a few moments, or just feel the need to decompress, serve, and connect with other TRiO folks.

**News Media/Coverage** – Kitty has a family member, Tamara Vaifanua, that is a news anchor/reporter at Fox 13. If her schedule allows, we hope to have her attend the conference.

**Newcomers** – Lindsay is organizing a Newcomer's Breakfast on Monday morning in lieu of the traditional Newcomer's Reception on Sunday night. This event will be held before workshops begin for the day and will be by invitation only, and invitations will be included in packets at check-in. The Governmental Relations Committee disseminated information to the membership regarding legislation, action alerts, and current issues, and answered related questions. Since each state requires an individualized approach, an active Governmental Relations Team who attended COE Policy Seminar worked on the actions alerts and current issues. COE Governmental Relations Conference calls, as well as ASPIRE Governmental Relations Conference calls, were used to discuss strategies.

The Governmental Relations Committee updated membership who attended their State Meetings on current TRIO issues.

The Government Relations Committee was available to advise and support first time attendees at the COE Policy Seminar in Washington, D. C.

On Monday, March 7, each state delegation met to prepare for their meetings with congressional offices on Tuesday, March 8. State Presidents scheduled a Policy seminar report at their state meeting to update membership.

When President Obama released his FY 2012 budget, the President had proposed an 8% increase for TRIO, from \$853.1 million to an appropriation of \$920.1 million. The House then passed a bill, HR. 1, which cut TRIO funding by 2.9% (for a loss of \$24.9 million). Through the leadership of Senators Baucus and Collins, and with the tireless efforts of the TRIO community, HR. 1 was defeated in the Senate. Leaders within the House and Senate then funded the government for the rest of FY11. The bill, H.R. 1473, the Full-Year Continuing Appropriations Act of 2011 passed easily with a vote of 260-167 in the House and 81-19 in the Senate. This bill, which reduced current spending levels by approximately \$38 billion, included a \$26.6 million cut to TRIO and a \$20.4 million cut to GEAR UP. The House passed its

FY 2012 budget resolution by a vote of 235-193. This legislation proposes drastic changes to the Pell grant program, reducing the maximum award to \$3,040, (45%) the lowest it's been since 1998. The Senate will take up its own budget proposal shortly, setting the stage for an even greater battle for funding in FY 2012. The TRIO community has continued to register their dissatisfaction with the White House. Dr. Mitchem has thanked the TRIO community for their tireless efforts during this serious fight for funding for the low-income, first generation students. Thank you to Dr. Mitchem and the COE staff for their hours of continuous work on the Hill.

During the months following COE Policy Seminar, Congress engaged in heated discussion regarding the debt ceiling. On August 2, 2011 congress approved the deal to increase the debt ceiling. The House approved the deal in a bipartisan 269-161 vote, and the Senate approved the deal 74-26. President Obama signed the Budget Control Act into law. The debt ceiling was increased by \$900 million. The impact of the debt ceiling deal is that funding for FY 2012 is capped at \$4.43 trillion, a \$7 billion cut from FY 2011. Congressional leadership has appointed a Joint Select Committee on Deficit Reduction or "Super Committee" to come up with at least \$1.2 trillion in additional spending cuts over the next ten years. If they fail to do so, automatic across-the-board cuts will be triggered to ensure the federal deficit decreases by \$1.2 trillion over the next ten years. The TRIO community continues to work tirelessly to avoid additional cuts, and will do so throughout the year.

# Benjamin A. Gilman International Scholarship

Over 1,200 scholarships of up to \$5,000 will be awarded this academic year for U.S. citizen undergraduates to study abroad. Award amounts will vary depending on the length of study and student need with the average award being \$4,000. Undergraduate students who are receiving federal Pell Grant funding at 2-year or 4-year colleges or universities are eligible to apply.

Students who apply for and receive the Gilman Scholarship to study abroad are now eligible to receive an additional \$3,000 Critical Need Language Supplement from the Gilman Program for a total possible award of up to \$8,000.

Critical Need Languages include:

- Arabic (all dialects)
- Chinese (all dialects)
- Turkic (Azerbaijani, Kazakh, Kyrgz, Turkish, Turkmen, Uzbek)
- Persian (Farsi, Dari, Kurdish, Pashto, Tajiki)
- Indic (Hindi, Urdu, Nepali, Sinhala, Bengali, Punjabi, Marathi, Gujarati, Sindhi)
- Korean
- Russian

• North Dakota- Through membership and recruitment emailed staff members who were not current members of ASPIRE to become members and as a result, they are currently at 41.

- Met their 10 for 10 goal that was set to receive free registration to the Policy Seminar. They are currently at 75% of their fair share and four schools will receive a discount if paid by the end of May and another school has made a commitment to pay. This amount should help exceed the year's fair share amount.
- North Dakota made 166% of fair share for the year.
- Thirty- nine members attended the state conference. This is 72% of professional staff in the state.
- <u>Colorado</u>- Currently has over 250 TRIO employees and current membership is 150. They will continue to recruit new members.
- Held their state meeting in Pueblo this year which drew in 90 registrants with 87 in attendance.

- Exceeded fair share in 2009-2010 and have over 10 contributors to COE. However, they did not meet their 10 for 10 campaign in time for the free policy seminar registration.
- <u>South Dakota</u>- ASPIRE State Conference attendance was 32 which is 71% of TRIO personnel in South Dakota and all new TRIO personnel in the state attended the state conference.
- A general session teleconference with Alvin Phillips was included in the agenda for the state conference in April. Carol Gritts updated South Dakota TRIO programs on the importance of meeting fair share and where the state was in reaching the goal of 100%.
- Wyoming- Had 26 members and a few non-members attend the state conference and 3 GEAR UP staff attended. Fair share is 102%
- Recruitment increase from 18 members to 30 which is a 67% increase
- Met 166% of Fair Share
- Rose over \$600.00 with silent auction and raffle at State Conference.
- Hosted a raffle and silent auction at state meeting which helped raised \$600.00.
- Utah- Increased membership by three between December and April from 52 to 55.
- 88% of membership attended the state conference and there were several attendees who chose to pay the higher registration fee rather than become members.

- Colorado- Had two new TRIO members attend their first Policy Seminar.

- Hosted their state meeting in Pueblo on April 29, 2011 and Lt. Joe Garcia was the luncheon guest speaker and two workshops were hosted by College in Colorado.

- Hosted a TRIO Achievers luncheon and in attendance were State Representatives from Mark Udall's office and Mike Bennett's office.
- Dawn Eckhart was unable to attend the state meeting but thanks to modern technology, she was able to speak to all those in attendance via Skype and provide updates.
- TRIO Advocacy Committee attended an event titled "A Day at the Capitol" this event was a collaboration between the Colorado School Counseling Association, the Colorado Counsel on High School/College Relations, the Rocky Mountain Association for College Admissions Counseling and Colorado Career and Technical Educators. They walked to the Capitol for the morning proceedings and a group was taken to the house floor while house proceedings were taking place. They also had an opportunity to observe from the senate gallery and tour the building.
- In the afternoon they had lunch and heard from a number of legislators. Rep. Ken Summers, Sen. Rollie Heath, Sen. Pat Steadman provided updates about the Counselor Core Program and the efforts being made to save the program and even continue it in years to come. Ron Brady (Sen. Hudakâs aide and former president of CEA) expressed support for counselors. The state budget and its impact on K-12 education occupied a great deal of our time. Tonette Salazar and Stacy Lestina gave further updates about the legislation related to education and school counseling. In the afternoon, they went back to the capital and observed committee work.
- Followed by this event, the TRIO Advocacy Committee hosted a meet and greet reception for local representatives Jim Reisberg from Greeley and Randy Fisher from Fort Collins and Gully Stanford was also present.
- Given the success of Day at the Capitol, and in recognition of the strength and effectiveness of the coalition, the Colorado Chapter of ASPIRE membership approved the commitment of \$1,000 to be part of such collaborative efforts. The goals of this coalition align closely with TRIO's State Initiatives and will also allow greater participation by TRIO professionals in advocacy activities, including Day at the Capitol. The coalition also offers numerous professional development opportunities and interaction with school and admissions counselors. Equally important is having access to the coalition's lobbyist, Salazar and Associates, that will be key in the process of passing legislation that supports educational success for low-income, first generation students in Colorado. Oscar Felix has agreed to head this collaboration.
- <u>Colorado-</u> The Colorado State Initiatives Committee will be meeting with Northern Colorado Congressman and Conservative Cory Gardner on Oct. 19<sup>th</sup> 2011.
- <u>South Dakota</u>- Dusty Johnson, Chief of Staff for Governor Daugarrd, was the keynote speaker at the state conference. TRIO professionals had an opportunity to ask questions and promote TRIO to one of the top government officials in the state.
- Non-TRIO staff from Great Lakes Higher Education presented a session on financial literacy.
- Wyoming- Field Reps from one senator and one representative's office attended the Alumni banquet

- TRIO and GEAR-UP staff and 2 students are meeting with Reps from our federal legislators on Sept. 15<sup>th</sup>.
- <u>Utah</u>- One GEAR- UP director attended the state meeting and one representative from Congressman Matheson's office.
- The TRIO Achievers Luncheon that was hosted at the state meeting.

Strategic Goal # 5: Further develop and utilize communication capabilities and network opportunities.

# Activities/Accomplishments:

- North Dakota-Lake Region SSS was featured on television and other TRIO programs have been listed in various newspapers.
- Now has an updated website with the most current information.
- <u>Colorado</u>- has updated their fact book and printed copies which were shared at the state meeting, Policy, and at a dinner in which state legislators were present.
- The Colorado ASPIRE website has been updated with current information and is user friendly
- <u>South Dakota</u>- Fact book was published and shared with the South Dakota legislative team in D.C for policy and with state legislators at South Dakota TRIO day.
- A statewide press release about South Dakota TRIO programs was provided to each TRIO program in the state. The press release promoted the activities of South Dakota TRIO day and TRIO programs across the state.
- The new South Dakota TRIO website was promoted at the state conference and TRIO professionals were encouraged to share the website with state education leaders.
- Wyoming- Northwest Community College had a TRIO article published
- \$250.00 in ASPIRE State Initiative matching grant fund will help to build media and Government Relations.
- Two Television spots ran that covered our State Legislative Education Access Day events.
- Have further developed WY ASPIRE website linking with ASPIRE website. The website now features a successful student each month. Also in the process of revising and printing WY ASPIRE brochure. All this with the help of the ASPIRE matching grant.
- <u>Utah</u>- In planning for the upcoming TRIO Day celebration, invitations have been sent to legislators and workshops are in the process of being set up. The fact book was assembled and distributed to lawmakers during Policy. The fact book has also been utilized to help raise funds for the Regional Conference as well as to provide TRIO information to local businesses and Universities.
- With ASPIRE State Initiative Matching grant a website has been compiled and is now in the process of being built.

Strategic Goal # 6: Assist program participants and alumni to advocate for TRIO.

Activities/Accomplishments:

- <u>Colorado</u>- A few TRIO Alumni were invited to participate at the State Conference but were unable to attend.
- North Dakota- Is planning on hosting a banquet to honor outstanding alum
- University of North Dakota TRIO holds alumni reunions on an annual basis.
- At the TRIO Achievers banquet a State Representative was the keynote speaker. Other speakers included staff from Bismarck State College, The Bank of North Dakota and COE.
- University of North Dakota uses Alumni to mentor students in other TRIO programs
- <u>South Dakota</u>- A general session on developing alumni relations was presented at the state conference in April.
- Wyoming- COE funded State Initiative for Alumni development with a \$350.00 matching grant and the Alumni banquet was hosted at the state conference and is slated to incorporate an Alumni database.
- An Alumni dinner will be held on Sept. 20<sup>th</sup> in Laramie for Southeast Wyoming Alumni and a state Rep will present on political advocacy.
- <u>Utah</u>- Hosted a TRIO Achiever Luncheon at the state meeting and the legislator that was in attendance was impressed with Alumni's stories. Several of the Alumni voiced the fact that they did not realize they were "TRIO Alumni" let alone TRIO Achievers. Alumni from UB, SSS, VUB and TS programs were present.
- They also met with a small committee from the state to define objectives/garner support.

#### Strategic Goal # 7: Strengthen relationships with state associations.

#### Activities/Accomplishments:

• The ASPIRE Executive Board continued the State Initiative matching fund program in 2011, offering up to \$1,500 to provide a 1:1 match from ASPIRE to help fund state initiative activities. Each state was encouraged to apply and was allowed to apply for up to \$250.00.

The following states applied and were awarded the \$250.00 matching grant:

- Colorado- Development of an updated fact book and registration fee for Alumni.
- Wyoming- Developed a website, brochure and hosted a TRIO alumni dinner.
- Montana- Hosted their second annual Best Practices in the last Best Place conference. Last year's focus was on two year education and this year scope was broadened to include all higher education in Montana including high school counselors.
- <u>Utah</u>- Developed a website which includes: directories, alumni resources, links to relevant associations and regulations that impact how we work and the services we provide.
